ENTRY GUIDELINES

Artist may submit up to 3 entries. One image for each 2D artwork and up to 2 images for each 3D artwork are required in JPEG format on CD. Entries will be juried by the submitted JPEG digital images. Please print or type your entry form and include your email address for notification of juror's results. If you don't have e-mail and your work is accepted, we will contact you by phone at the number you provide. Completed and signed Entry Form, payment and CD are to be mailed or delivered to:

Entries must be received by Saturday, April 12 at 5:00 p.m. Entries that do not follow the guidelines may not be considered for the show.

DIGITAL FORMAT

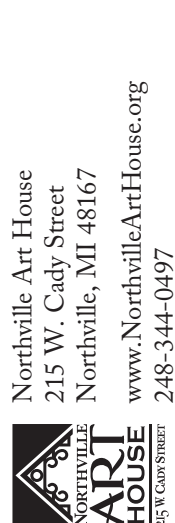
Digital images are to be submitted in JPEG format on CD. CDs that require additional software downloads for viewing will not be accepted (Kodak EasyShare for example). All digital images must be labeled with: artist's first initial, last name, title, and size of art (example: **DSmith_Untitled_24x36.jpg**). Images must not exceed 3MB. Label CDs with the artist's name. No e-mailed entries. CDs will not be returned.

DELIVERY AND PICKUP

Artwork may be hand delivered or shipped. All shipping costs, including the return shipping and liability for damage, are the responsibility of the artist. The Art House will take precautions to protect the artwork at all times but will not be responsible for loss or damage. All artwork must be delivered and picked up on the dates specified in this call for entries form.

ENTRY FEES

The non-refundable entry fee is \$35 (\$25 for Northville Art House members) which entitles each artist to submit up to three entries. Cash, check or credit cards are accepted. Please make checks payable to the Northville Art House.



The Northville Art House is located in downtown Northville — 1 block South of Main Street and 2 blocks West of Center Street. The Northville Art House serves the Northville and surrounding communities by providing quality events and activities to enrich its citizens' lives through the arts.

JUROR:

A native of Detroit, renowned fine artist **Robert Schefman** is currently the Chair of the Foundations Department, and Associate Professor at The College for Creative Studies. Robert holds a BFA from Michigan State University, and an MA in Sculpture and MFA from the University of Iowa. His work, in both solo and group exhibitions, has been shown extensively in galleries and museums in New York and Michigan, (Including the DIA) and throughout the United States in numerous private and public collections. The Northville Art House will exercise professional care in handling all entries, but cannot assume liability for loss or damage, however caused, while works are in our possession or in transit. It is recommended that each artist provide his or her own insurance.

SALES AND COPYRIGHTS

35% commission will be charged on all art for sale. Your entry into the show grants permission to the Art House to photograph and reprint your art for promotional and/or educational purposes only. Artwork in an exhibition may not be removed for the duration of the show.

ELIGIBILITY

Artists, 18 and over, may submit a maximum of 3 original works in any media, created within the last 2 years, and not previously exhibited at the Northville Art House. Artwork cannot be bigger than 4 x 5 feet. No video as we do not have the facilities to accommodate. 2D work must be framed and **ready for hanging with a wire** (no sawtooth or stick-on hangers, etc.). Ceramic pieces should have a wire, notch or secure method of hanging. It is preferred that all works submitted be for sale.
