The **Northville Art House** invites you to the 12th annual, 3-day festival held in historic Northville, a picturesque enclave between Ann Arbor and Detroit, Michigan. **Arts and Acts** features over 100 unique fine artisans and crafters in three fairs – *Art in the Sun*, *Maker's Mart* and *Young Artist Juried Art Fair*. If you are interested in having your food concession at our show, fill out the form below. **Your application must be received by Saturday, April 25th, 2021.** You will receive a map and instructions two weeks prior to the show. This is a golden opportunity for you to showcase your talents and food products – and make a sizable profit. Booth space is 10' by 10'. There are a limited number of double booth spaces available. *Every effort will be made to minimize duplicate products.*

Please be aware that you must apply for a temporary food license and most food items will require a tent approved by the Wayne County Health Department. You will need to contact the Wayne County Health Department at 734-727-7400 to obtain your license. We also need a copy of your "Certificate of Liability Insurance" issued by your insurance agent showing the limits of coverage for 1) General Liability including Products Liability, 2) Automobile Liability and 3) Workers Compensation and Employers' Liability. ***The City of Northville and the Northville Art House, Inc. MUST be indicated as additional insured on the Certificate of Liability Insurance.*** The minimum General Liability coverage limits should be \$1,000,000 for each occurrence and \$2,000,000 general aggregate. **A copy of the ENDORSEMENT (Endorsement Form CG 20 26 is the recommended policy Endorsement form.) is also required to accompany ALL Certificates of Insurance.** The Northville Fire Department will require you to have a fire extinguisher with a current inspection tag: 30A40BC.
